2. **Exclusivity.** In order for the Client to receive the best service and most compelling photos apossible, the Photographer should be the exclusive professional photographer for the wedding. Additional professional photographers may be employed only with prior written permission from the photographer. The Client agrees that wedding party should take direction only from the Photographer during formal portrait and posed subject sessions.

IT is the clients' responsibility to negotiate any photography limitations or requirements during the wedding ceremony with the wedding officiant to preserve the sanctity and tradition of the ceremony.
